Course Description:

This 2- hour course will provide a clear, practical overview of the major changes introduced through NJDEP's SRRA Amendments' recent rule adoption. Participants will learn how updates to the Administrative Requirements for the Remediation of Contaminated Sites (N.J.A.C. 7:26C), Technical Requirements for Site Remediation (N.J.A.C. 7:26E), and the Industrial Site Recovery Act Rules (N.J.A.C. 7:26B) affect the site remediation process in New Jersey.

Key highlights include:

Updated administrative requirements such as public notification, discharge reporting, RAOs, remedial action permit changes, deed notices, CEAs, and enforcement updates. Technical requirement changes involving variances, IECs, receptor evaluations, historic fill investigations, remedial investigations, and updated remedial action expectations including migration-to-groundwater and fill management. Brief rule updates for ISRA (7:26B) and heating oil tank remediation (7:26F).

Designed for environmental professionals, this course delivers essential regulatory updates to help ensure compliance and streamline remediation projects under SRRA 2.0.

This program helps practitioners verify that laboratory performance meets DKQP requirements and supports project-specific data quality objectives.
